

# ***BS & DIN Battery Warranty***

## ***36 Month Guarantee***

Century Yuasa Batteries Pty Ltd guarantees to the original user that Century branded BS and DIN vented lead acid (wet) batteries will be free from defects in materials or workmanship for a period of thirty six (36) months from date of shipment, provided that the installation occurs within one (1) month of the date of shipment. Should Century Yuasa Batteries Pty Ltd find any cell to be defective in materials or workmanship as above, it will be repaired or replaced free of charge.

## ***Pro-Rata Warranty***

Century Yuasa Batteries Pty Ltd further warrants to the original user that Century branded BS and DIN vented lead acid (wet) batteries will have a service life of 1,500 cycles @ 80% daily depth of discharge or sixty (60) months from date of shipment, whichever occurs first. This service life is conditional on the battery delivering a minimum of 80% of its published 5-hour rated capacity from the date of shipment and when used in strict accordance with the Century Performance Batteries 'Instruction Manual and Log Book' and supplying the log book data containing the complete service history of the battery when requested by a Century Yuasa Batteries Pty Ltd representative.

If the above conditions are met, the battery will be deemed to have failed if after a complete recharge, the battery's discharge capacity at the 5-hour rate at 30°C to a final voltage of 1.70 volts per cell is below 80% of the battery's published 5-hour rated capacity.

Should Century Yuasa Batteries Pty Ltd find any cell is in breach of this warranty, Century Yuasa Batteries Pty Ltd at its sole discretion will repair or replace the cell or allow the original user to apply a credit for the pro-rata basis of the proportion of the warranty term remaining. The pro-rata credit shall be based on the original purchase price of the cell and this credit can only be applied to the current purchase price of an equivalent battery from the current range of battery products offered by Century Yuasa Batteries Pty Ltd. Other than as set out in this warranty, Century Yuasa Batteries Pty Ltd shall not be liable for any losses or damages whatsoever that may be suffered, including but not limited to consequential damages.
